As per the unanimous decision of the meeting of the Joint Action Committee held on 21<sup>st</sup> September, 2011, we hereby intimate that the BSNL Executives & Non-Executives will go on One Day Strike on 10<sup>th</sup> October, 2011 on the following demands:-



**Demands:**


1. No VRS
2. Immediate payment of Bonus (PLI)
3. Restoration of Medical Allowance, Leave encashment and LTC
4. Immediate conclusion of the process of ITS absorption
5. 78.2% IDA Fixation.
6. Immediate procurement and supply of equipments including GSM, BB Modem, Cables, Trans SMS, MLLN etc. and implementation of important business projects like ERP, NGN and Transmission NMS.
7. Government Policy related issues:
  - a) Compensation for loss making rural services according to policy commitments.
  - b) Pension Contribution to DOT only on actual basic pay instead of maximum of the pay scale.
  - c) Refund Rs.8313 crore paid towards non-standard BWA spectrum band.
  - d) Grant of flexibility in selecting circles of choice for 3G Spectrum.
  - e) Access Deficit Charges (ADC) should be quantified through adequate and appropriate mechanism and paid to BSNL.
  - f) Reimbursement of Licence Fee to BSNL as assured at the time of corporatisation.
  - g) Refund of 'Notional Loan' of Rs. 7500 crore with interest collected by DOT from BSNL.
  - h) Discontinue all Telecom Advisory Committees


One day massive fast will also be organised at SSA/Circle/Corporate Office levels on 27<sup>th</sup> September, 2011 in support of the strike.


The agitational programme have been decided in view of the non-settlement of the above long pending demands and also no fruitful discussions with the unions/JAC.


